How to become a CMC Member

- 1. Submit a membership application form at www.CMC.ca/Membership
- CMC's membership team will acknowledge your request and initiate the approval process.
- 3. CMC's Board of Directors will review membership applications at their next scheduled meeting.

Criteria

- Membership is considered for organizations interested in furthering the purposes of CMC.
- Membership applications must receive the approval of CMC's Board of Directors.

What happens next?

When a CMC membership is approved, we will forward a welcome package to confirm terms and details as well as:

- Arrange to jointly announce the new membership in a news release and on social media.
- Request your logo high quality PNG, SVG, EPS, or AI and permissions for use.
- Extend invitations to sign up for news &/or get a CMC Account.
- Confirm your organization's Member Representative. The Member Representative, by appointment, represents your organization in the conduct of the affairs of CMC Microsystems and votes on matters that come before Members at the Annual Meeting. Annual Meeting details will be forwarded separately.

Levels of Membership

Class A: Post Secondary Institutions in Canada Class B: Industry in Canada Class C: Not-for-profit R&D organizations in Canada Class D: Other organizations – Worldwide

📚 Class A: Post Secondary Institutions in Canada

Post-secondary institutions of learning located in Canada principally funded by governments within Canada (whether federal or provincial or municipal or any combination of the same).

Each Class A member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class A members do not pay member fees and have a term of membership of five (5) years.

Class B: Industry in Canada

Industry and for-profit organizations located in Canada.

Each Class B member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class B members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.

Levels of Membership

Series C: Not-for-profit R&D organizations in Canada

Not-for-profit R&D Organizations in Canada.

Each Class C member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class C members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.

Examples of Class C members include government and/or government funded R&D organizations in Canada that commit resources toward research and/or development, training of highly qualified personnel (HQP), and/or collaborations related to accelerating research and innovation in advanced technologies.

Class D: Other Organizations – Worldwide

Organizations, whether in Canada or not, interested in furthering the purposes of the Corporation, or that have a peripheral interest in the mission of the Corporation.

Each Class D member is entitled to receive notice of and attend all meetings of members (excluding meetings at which only members of another class are entitled to attend). Class D members are not entitled to vote at any meetings of members (unless the Act otherwise provides).

Class D members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.

Terms and Conditions

Membership Dues

Class A: Post Secondary Institutions in Canada – Complimentary

Class B: Industry in Canada – \$500 / 2-year term

Class C: Not-for-profit R&D organizations in Canada – \$200 / 2-year term

Class D: Other organizations worldwide - \$500 / 2-year term

Post-secondary institutions in Canada do not pay member fees at any time. For all other organizations, the first 2-year term fee is waived.

Termination of Membership

A membership in the Corporation is terminated when:

- The member resigns by delivering a written resignation to the chair of the board of the Corporation (effective on the date specified in the resignation).
- The corporation is liquidated or dissolved.
- A member fails to maintain qualifications for membership.
- The member is expelled in accordance with any discipline of members or is otherwise terminated in accordance with the articles or by-laws; or
- The member's term of membership, if any, expires and is not renewed within 30 days of the expiry date.
