Terms and Conditions

Membership in the Corporation shall be limited to organizations interested in furthering the purposes of the Corporation and shall consist of those organizations whose application for admission as a member has received the approval of CMC's Board of Directors. There are four classes of eligibility:

 - > Class D: [Other Organizations - Worldwide](#)

Class A Membership: Post Secondary Institutions in Canada

Post-secondary institutions of learning located in Canada principally funded by governments within Canada (whether federal or provincial or municipal or any combination of the same).

Each Class A member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class A members do not pay member fees and have a term of membership of five (5) years.

Class B Membership: Industry in Canada

Industry and for-profit organizations located in Canada.

Each Class B member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class B members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.



Class C Membership: Not-for-profit R&D Organizations in Canada

Class C Membership Eligibility

Not-for-profit organizations located in Canada.

Each Class C member is entitled to receive notice of, attend and vote at all meetings of members, and is entitled to one (1) vote at such meetings (excluding meetings at which only members of another class are entitled to vote separately).

Class C members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.

Examples of Class C members include government and/or government funded R&D organizations in Canada that commit resources toward research and/or development, training of highly qualified personnel (HQP), and/or collaborations related to accelerating research and innovation in advanced technologies.

Other Organizations - Worldwide

Class D Membership Eligibility

Organizations, whether in Canada or not, interested in furthering the purposes of the Corporation, or that have a peripheral interest in the mission of the Corporation.

Each Class D member is entitled to receive notice of and attend all meetings of members (excluding meetings at which only members of another class are entitled to attend). Class D members are not entitled to vote at any meetings of members (unless the Act otherwise provides).

Class D members must pay a fee according to a fee schedule published by the Corporation and have a term of membership of two (2) years.



Additional Information:

Termination of Membership

A membership in the Corporation is terminated when:

- > The corporation is liquidated or dissolved.
- > A member fails to maintain qualifications for membership.
- > The member resigns by delivering a written resignation to the chair of the board of the Corporation (effective on the date specified in the resignation).
- > The member is expelled in accordance with any discipline of members section or is otherwise terminated in accordance with the articles or by-laws; or
- > The member's term of membership, if any, expires and is not renewed within 30 days of the expiry date.

Definitions

- > "**Act**" refers to Canada Not-for-profit Corporations Act.
- > "**Board**" means the board of directors of the Corporation.
- > "**Corporation**" means Canadian Microelectronics Corporation/Societe Canadienne de Micro-Electronique (operating as CMC Microsystems/CMC Microsystemes).
- > "**Meeting of Members**" includes an annual meeting, or a special meeting of members of the Corporation.
- > "**Member**" means a member of the Corporation as defined in By-Law No. 2, sections 9, 9A, 9B, 9C and 9D.
- > "**Member Representative**" means the one (1) person appointed by a member to represent it in the conduct of the affairs of CMC Microsystems (the Corporation).
- > "**Purposes**" refers to the purposes of the Corporation certified by Corporations Canada.
